DUMP TRUCK (BETTY)

Latest Review 7/1/2026

Brand Ford

Model F600 Dump truck

FORD RANGER Water District Pick-up

Latest review 6/2026

Hard start situation. Vehicle previously ran in June 2026. Josh and Daryl will troubleshoot. Issues with neutral safety switch and shifter. Recommending that truck is sold in 2027

CAT 239D TRACK-STEER

Last review 8/29/2026

Per Holmes request Chris MacDonald started unit and exercised all hydraulics, checked fluid levels. Unit is in great shape and is prepared for season work. Holmes operated the unit August 29 for 2 hours for grading and surface work at Parli's property. New filters have been purchased and will be replaced in October.

D4 CAT Bulldozer

Holmes has been in contact with Hawthorne Caterpillar to determine our ability to disperse of the unit. Our CAT representative explained that the bulldozer is considered illegal to operate in the state of California since an emissions act was passed in 2005 deeming the unit obsolete and unsaleable. Holmes has reached out to Roberto to see if someone in Mexico will want it. Andria may have a lead on an individual who may want it for parts. Hawthorne CAT explained the state fines are hefty if it is used by CCWD or sold to a California party. Most likely the outcome would be a yard art non-operational role and given away.

CAT 303.5 Excavator

Per Holmes request, Chris MacDonald started the unit and exercised all hydraulics per procedure. Fluid levels were checked. The unit is in great condition and prepared for upcoming season work. Filters were purchased by Holmes and will be replaced in October.

Trash is an issue for CCWD. There are several 55 gallon canisters in the equipment sheds with various materials and trash that need to be disposed of. Holmes will handle and haul off in October with Chris MacDonalds help.

Holmes recommends that CCWD has their own trash service with unlimited construction type usage. Ramona Waste disposal can provide that. Trash disposal will increase as poly pipe is replaced during the upcoming season.
