Credit Card Users - still keep receipts when using credit card and send receipt images to bookkeeper so expenses can be traced for Audit purposes.

Year-end Close - June 30th is our fiscal year-end date. Close of year 2023-2024 will likely occur by *September 1* via bookkeeper efforts.

Audit - begins *September 1* once year-end closes and documents sent to CPA (Sonnenberg). Audit to be completed in November timeframe to avoid holidays and end of calendar year.

State Transaction Report - due Jan 31, 2025. This tells the state our standing finances. We use the same actual numbers as our Audit to align our State reporting to our Federal reporting that's why we finish the Audit *before* the State Report.
